## **Governor Scott Walker Declares September Coastal Awareness Month**

\$1 Million in Grants Available to Improve Wisconsin's Coastlines

Governor Scott Walker has proclaimed September 2014 as Coastal Awareness Month in Wisconsin in recognition of the importance the Great Lakes play in the state. The Governor's proclamation is a reminder for the people of Wisconsin to protect, promote and enjoy the state's Great Lakes as Lake Michigan and Lake Superior are integral to Wisconsin's economy, recreation, tourism, cultural history and quality of life.

In recognition of Coastal Awareness Month and the importance of the Great Lakes, the Department of Administration's Wisconsin Coastal Management Program is also announcing that nearly \$1 million in grants are available to help improve Wisconsin's coastlines. The Coastal Management Program is seeking proposals to enhance, preserve, protect and restore resources within the state's coastal zone. This includes all counties adjacent to Lakes Superior and Michigan, with their nearly 1000 miles of shoreline.

Grants are available for coastal wetland protection and habitat restoration, nonpoint source pollution control, coastal resource and community planning, Great Lakes education, public access and historic preservation. The grants are federally funded through the National Oceanic and Atmospheric Administration (NOAA), but administered through the Wisconsin Coastal Management Program.

**The deadline for submitting a grant application is November 3.** Communities, tribal governments, universities and non-profits should keep the following items in mind when submitting an application:

- There is a cost-share requirement for all projects. The matching funds must come from non-federal sources, and may be in the form of in-kind contributions.
- For habitat restoration and construction projects, be sure to include copies of all required permits or permit applications, as well as title documentation with the application materials.
- For all projects, be sure to include copies of required documentation and letters of support.
