# AGENCY DESCRIPTION

The department is headed by an eight-member board, including two consumer representatives, appointed by the Governor with the advice and consent of the Senate for staggered six-year terms. The Governor appoints a secretary to administer the department. The mission of the department is to assure the safety and quality of food, healthy animals and plants, efficient use of agricultural resources in a quality environment, fair business practices for the buyer and seller, and to promote the interests of agriculture. The department's programs are administered through six divisions: Food Safety; Trade and Consumer Protection; Animal Health; Marketing; Agricultural Resource Management; and Management Services.

The office of the secretary includes the deputy secretary, executive assistant and legal counsel. Attached directly to the secretary's office are the federal-state Agricultural Statistics Service and the Office of Outreach and Policy.

## MISSION

The mission of the department is to serve the citizens of Wisconsin by developing, implementing and communicating public policies that:

- Promote, protect and strengthen the financial soundness and competitive viability of Wisconsin's agricultural industry.
- Assure citizens' safety, security and confidence in the agricultural and nonagricultural products and services of our marketplace.

# PROGRAMS, GOALS, OBJECTIVES AND ACTIVITIES

#### **Program 1: Food Safety and Consumer Protection**

Goal: Assure fair business practices for buyers and sellers and safe products for consumers and the environment by establishing and enforcing legal standards, by mediating disputes between consumers and businesses, and by providing consumer education and information to Wisconsin citizens.

Objective/Activity: Return to consumers and government money gained through unfair business practices.

#### **Program 3: Marketing Services**

Goal: Identify and develop new profit centers and opportunities for farmers and agribusiness and provide information, programs and services that can result in increased income. Create an environment that fosters new development and opportunities in agriculture.

Objective/Activity: Develop a more diversified and profitable agriculture industry in Wisconsin through agricultural development and diversification grants and educational/outreach activity.

#### Program 7: Agricultural Resource Management

Goal: Improve environmental, public health and livestock protection in Wisconsin.

Objective/Activity: Reduce the danger of unintended exposure to agricultural pesticides and other hazardous farm chemicals.

#### **Program 8: Central Administrative Services**

Goal: Support the vision and goals of the department by partnering with management and staff to provide information, advice and expertise that support the needs of the business.

Objective/Activity: Resolve computer/computer user problems, to the user's satisfaction, in a timely manner.

#### 1. Land and Water Resource Management

The Governor recommends \$7 million in new GPR-supported general obligation bonding for grants to counties for implementation of land and water resource management plans, including cost-share grants to landowners for installation of practices to improve water quality through reduction of nutrients discharged to waters of the state. In addition, limit the Department of Natural Resources and Land and Water Conservation Board's authority to extend priority watershed ending dates beyond those in effect on January 1, 2001. The Governor also recommends converting and consolidating nonpoint source pollution abatement appropriations to more accurately reflect the source of funding for this program. See Miscellaneous Appropriations, Item #4.

## 2. Farmland Preservation Credit Payback

The Governor recommends modifying the credit payback requirement of the Farmland Preservation Program by replacing the property lien with a flat per acre conversion fee. A landowner would be required to pay a \$50 per acre fee prior to release from a farmland preservation agreement or a \$60 per acre fee prior to removal of the land from exclusive agricultural zoning.

## 3. Drainage Districts

The Governor recommends streamlining the Department of Natural Resources (DNR) drainage district permit process associated with removing dams or obstructions, or dredging, widening or straightening a navigable stream. In addition, exempt activities performed by a drainage district primarily for agricultural purposes from DNR permitting requirements if the activity is approved by the department after consulting with DNR.

#### 4. Producer Security Fund

The Governor recommends replacing the current milk, grain and vegetable producer security programs with a producer security fund. The fund will reimburse producers for defaults by warehouses and processors. Fund revenue will derive from a variety of license and inspection fees. The fund will receive an initial loan of \$2,000,000 SEG from the agrichemical management fund and will be backed by surety bonds. The Governor also recommends transferring 12.12 FTE PR-O positions and associated PR-O spending authority from the current security program appropriations to a new SEG fund appropriation. The producer security fund will free approximately \$170 million in industry capital and reduce industry costs by approximately \$20 million over ten years. This item is part of the Governor's Rural Economic Development Initiative. See details of the entire initiative under the Office of the Governor, Item #1.

## 6. Agricultural Development and Diversification Grants

The Governor recommends providing Indian gaming revenue to increase the agricultural development and diversification grant program. The Governor also recommends authorizing the department to make grants and provide technical assistance to support preliminary research to increase the value of agricultural products. This item is part of the Governor's Rural Economic Development Initiative (see details of the entire initiative under the Office of the Governor, Item #1). #### 7. Lead Arsenate Contamination

The Governor recommends converting a vacant position and providing additional spending authority from the agrichemical management fund for a program to track properties that have been contaminated with pesticides made with lead arsenate. Lead arsenate pesticides were used extensively on apple and cherry orchards from around 1900 to the 1950s. Because of serious health effects, lead arsenate pesticides have been banned in the United States.

The Governor recommends the conversion of a vacant position and increased funding to improve inspection of nursery stock and Christmas trees and control of plant pests such as the gypsy moth and pine shoot beetle. The Governor also recommends expanding the department's pest-abatement authority to nonagricultural lands.

The Governor recommends converting 1.0 FTE SEG project position to permanent and providing funding from the agrichemical management fund to continue and expand the K-12 integrated pest management (IPM) training program. The program assists public and private school staff in the use of IPM to reduce pesticide exposure to children and staff.

#### 10. Johne's Disease Staffing

The Governor recommends transferring a vacant position from the agricultural resource management program to support the Johne's livestock disease control program.

#### **11. Telephone Solicitation Regulation**

The Governor recommends improving telephone solicitation regulation by: (a) requiring telephone solicitors to disclose their names, the purpose of the call, whether they are employed by a telemarketing firm, and the business on behalf of which they are calling; (b) prohibiting telephone solicitation of persons who have provided written notice that they do not wish to receive such solicitation; and (c) prohibiting telephone solicitors from blocking caller ID. These regulations may be enforced by the department or by district attorneys after consulting with the department. Violators are subject to a civil forfeiture. See District Attorneys, Item #4.

The Governor recommends transferring 9.3 FTE GPR consumer protection positions and related spending authority to the department from the Department of Justice (see Department of Justice, Item #8). This action will complete the transfer of consumer protection resources to the department from the Department of Justice that was begun in the 1995-97 biennial budget to improve the efficiency and effectiveness of state consumer protection efforts. The Governor also recommends imposing a ten percent fee on court-ordered consumer protection fines and forfeitures and using the revenue generated to offset rising investigation costs and to fund additional investigations.

#### 13. Federal Agricultural Policy Reform

The Governor recommends continuing to provide \$50,000 GPR annually to support the collective efforts of Midwestern states and organizations toward achieving meaningful reform of federal agricultural policy. This item extends the sunset date of the federal policy reform appropriation to 2005.

#### 14. Appropriation Consolidation

The Governor recommends consolidating certain appropriations relating to: (a) gifts and grants; (b) state contractual services; (c) marketing general program operations; (d) plant protection; (e) central administrative services general program operations; (f) laboratory services; and (g) agrichemical management.

#### **15. Eliminate Obsolete Statutes**

The Governor recommends repealing the World Dairy Center Authority because it has completed its mission. The Governor also recommends eliminating the farms for the future fund because no federal revenues for this purpose have been received.
