### AGENCY DESCRIPTION

The fund was created in 1997 Wisconsin Act 27 to expand lending activities related to the water quality of our state. The fund encompasses the former Clean Water Fund (now known as the Clean Water Fund Program) and operates three lending programs for the purposes of construction and expansion of wastewater treatment facilities; construction and expansion of public drinking water facilities; and remediation of municipally-owned contaminated lands. The Department of Natural Resources has lead responsibility for the environmental and project management aspects of the programs operating under the fund. The Department of Administration is responsible for the financial management of the fund.

## PROGRAMS, GOALS, OBJECTIVES AND ACTIVITIES

#### **Program 1: Clean Water Fund Program Operations**

Goal: Protect the water quality of our surface and ground waters by funding the repair, rehabilitation, expansion and construction of municipal wastewater collection and treatment facilities.

Goal: Provide financial resources to promote projects that serve to remediate contaminated lands so that they may be restored for useful purposes.

#### Program 2: Safe Drinking Water Loan Program Operations

Goal: Protect public health by providing the financial resources necessary for communities to maintain adequate public drinking water systems.

Goal: Encourage communities to undertake needed drinking water supply construction projects in a time frame that is in the best interests of the community and the environment.

### Program 3: Private Sewage System Program

Goal: Provide counties and certain municipal governments with loans so that they may make grants to eligible individuals for the repair or replacement of private sewage treatment systems.

#### 1. Program Modifications

The Governor recommends the following changes to the Environmental Improvement Fund:

- <u>Clean Water Fund Program</u>. (a) Provide an additional \$85 million in general obligation bonding authority and \$92 million in revenue bonding authority for the Clean Water Fund Program. (b) Set the Clean Water Fund Program subsidy level at \$90 million. (c) Change the requirement that two-thirds of wastewater flow for any new wastewater collection systems be from homes built prior to October 17, 1972, to ten years prior to the facility plan approval date in order for a municipality to qualify for state subsidies under the Clean Water Fund Program.
- Safe Drinking Water Loan Program. (a) Set the Safe Drinking Water Loan Program subsidy level at \$10.9 million. (b) Change the intent to apply deadline for the Safe Drinking Water Loan Program from four to six months prior to the following fiscal year so that it is consistent with other programs under the environmental improvement fund.
- 3. Land Recycling Loan Program. Set the Land Recycling Loan Program subsidy level at \$9.1 million.
- 4. <u>Wisconsin Fund</u>. Eliminate residual bonding authority in the Wisconsin Fund Program.
