AGENCY DESCRIPTION

The Court of Appeals consists of sixteen judges elected for staggered six-year terms. The court is divided into four panels located in Milwaukee, Waukesha, Wausau and Madison and is supervised by a chief judge appointed by the Supreme Court.

The Court of Appeals has original jurisdiction to issue prerogative writs and appellate jurisdiction over all final judgments and orders of the Circuit Courts, which can be appealed as a matter of right.

The Court of Appeals usually sits as a three-judge panel to dispose of cases on their merits. However, certain categories of cases, including small claims, municipal ordinance and traffic violations, and mental health, juvenile and misdemeanor cases, may be heard by a single judge. The Court of Appeals provides a written opinion containing a summary of the reasons for a decision made by the court.
