AGENCY DESCRIPTION

The department was created by Chapter 479, Laws of 1929. The department is headed by a nine-member board, including two consumer representatives, appointed by the Governor with the advice and consent of the Senate for staggered six-year terms. The Governor also appoints a secretary, with the advice and consent of the Senate, to administer the department. The department's programs are administered through six divisions: Food Safety, Trade and Consumer Protection, Animal Health, Agricultural Development, Agricultural Resource Management, and Management Services.

The Office of the Secretary includes the deputy secretary, executive assistant and budget director. Attached directly to the secretary's office are the Office of Legal Counsel and the Wisconsin Agricultural Statistics Service.

MISSION

The mission of the department is to serve the citizens of Wisconsin by developing, implementing and communicating public policies that:

 Promote, protect and strengthen the financial soundness and competitive viability of Wisconsin's agricultural industry; and Assure citizens' safety, security and confidence in the agricultural and nonagricultural products and services of our marketplace.

PROGRAMS, GOALS, OBJECTIVES AND ACTIVITIES

Program 1: Food Safety and Consumer Protection

Goal: Assure fair business practices for buyers and sellers and safe products for consumers and the environment by establishing and enforcing legal standards, by mediating disputes between consumers and businesses, and by providing consumer education and information to Wisconsin citizens.

Objective/Activity: Return to consumers and government money gained through unfair business practices.

Program 3: Marketing Services

Goal: Identify and develop new profit centers and opportunities for farmers and agribusiness and provide information, programs and services that can result in increased income. Create an environment that fosters new development and opportunities in agriculture.

Objective/Activity: Develop a more diversified and profitable agricultural industry in Wisconsin through agricultural development and diversification grants, and educational and outreach activities.

Program 7: Agricultural Resource Management

Goal: Improve environmental, public health and livestock protection in Wisconsin while allowing for the efficacious and wise use of fertilizer, pesticide and other agrichemical materials.

Objective/Activity: Allow Wisconsin farmers, businesses and homes to safely and conveniently dispose of unwanted pesticides and other hazardous chemicals at public collection sites.

Program 8: Central Administrative Services

Goal: Support the vision and goals of the department by partnering with management and staff to provide information, advice and expertise that support the needs of the business.

Objective/Activity: Resolve computer and computer-user problems, to the user's satisfaction, in a timely manner.

The Governor recommends providing \$12 million over the biennium for cost-share grants to farmers to develop nutrient management plans and other nonpoint source water pollution control practices. The Governor also recommends providing \$7 million in new GPR-supported general obligation bonds for grants to counties for implementation of land and water resource management plans, including cost-share grants to landowners. The Governor further recommends providing \$75,000 in FY08 and \$40,000 in FY09 to establish and operate a manure management advisory system to provide information to assist farmers and manure applicators in identifying the least risky fields and times to apply manure.

The Governor recommends providing funding to help businesses install agricultural chemical pollution prevention practices to protect the environment and public health and reduce the need for future remediation. The Governor also recommends increasing the maximum lifetime agricultural chemical cleanup award a business may receive to a cleanup reimbursement maximum of \$400,000 and a combined cleanup and pollution prevention maximum of \$500,000. The Governor further recommends providing funding to establish a lead and arsenic contaminated soils program to inform the public about the dangers of exposure to lead and arsenic contaminated residues in soil.

The funding will enable the department to award up to ten additional grants per cycle to local authorities to conduct collections of agricultural, business and hazardous household waste.

The Governor recommends providing funding for research and development of anaerobic digesters at farms participating in the discovery farms program under the Wisconsin agricultural stewardship initiative. This provision builds on measures enacted in 2005 Wisconsin Act 141 to promote energy efficiency and energy derived from renewable resources.

The Governor recommends consolidating grant and loan programs for companies and researchers to develop and commercialize renewable fuel and energy technologies at the Department of Commerce. See Department of Commerce, Item #1.

6. Farmland Preservation Program Streamlining

The Governor recommends allowing the department, rather than the Land and Water Conservation Board, to certify county farmland preservation plans and zoning ordinances, and allowing county self-certification. The Governor also recommends restructuring payback requirements when land is rezoned out of a preservation area by eliminating the requirement that the landowner repay farmland preservation tax credits received and instead require the landowner to pay a \$100 per acre conversion fee to counties to support preservation planning and monitoring activities.

7. Invasive Species Violation Penalties

The Governor recommends increasing the maximum allowable penalties for violating nursery and quarantine laws from \$200 to \$1,000 for a first offense and \$5,000 for any subsequent offense, and creating civil forfeiture and criminal penalty options for such violations. This change will align penalty levels with other states and help to combat the threat of invasive species such as the emerald ash borer.

The Governor recommends improving the provision of state legal services by consolidating attorneys and legal support staff under the secretary of the Department of Administration on July 1, 2008. The Department of Administration secretary will determine the assignment of attorneys to individual agencies. To achieve this, the Governor recommends transferring 7.5 FTE positions to the Department of Administration. The Governor further recommends retaining the funding associated with these positions in the department to purchase legal services from the Department of Administration. In addition, 1.0 FTE unclassified position is created to provide general counsel services. See Department of Administration, Item #1.

9. Transfers from Agricultural Chemical Cleanup Fund

The Governor recommends transferring \$250,000 in FY08 and \$100,000 in FY09 from the agricultural chemical cleanup fund to the food regulation appropriation under s. 20.115(1)(gb), and \$125,000 in each year to the animal health inspection, testing and enforcement appropriation under s. 20.115(2)(ha) to address projected deficits in the program revenue appropriations.
