AGENCY DESCRIPTION

The board is required by s. 146.59, Wisconsin Statutes, to negotiate and enter into a contractual services agreement with the University of Wisconsin Hospitals and Clinics Authority. This agreement between the board and authority covers the provision of services to the authority by the employees of the board represented by the Wisconsin State Employees Union.

The membership of the board includes 13 voting and 2 nonvoting members designated as follows: three members appointed by the Governor with the advice and consent of the Senate, for three-year terms; each co-chairperson of the Joint Committee on Finance or a member of the committee designated by that co-chairperson; three members of the Board of Regents appointed by the president of the Board of Regents; the chancellor of the University of Wisconsin-Madison or his/her designee; the dean of the University of Wisconsin-Madison Medical School; a chairperson of a department at the University of Wisconsin-Madison Medical School, appointed by the chancellor of the University of Wisconsin-Madison; a faculty member of a University of Wisconsin health professions school, other than the University of Wisconsin-Madison Medical School, appointed by the chancellor of the University of Wisconsin-Madison; the secretary of the Department of Administration or his/her designee; and two nonvoting members appointed by the Governor, one representing the professional represented employees and one representing the employees represented by the Wisconsin State Employees Union.
