AGENCY DESCRIPTION

The department is headed by the Attorney General, an elected constitutional officer. The department provides legal, criminal investigatory and other law enforcement services for the state, as well as services to the victims of crimes.

The Division of Legal Services prosecutes major crimes, handles felony appeals, represents the interests of the state in court, advises state officers and agencies regarding their legal rights and responsibilities, and represents those officers and agencies in court. The division advises county district attorneys on matters within the jurisdiction of their offices. The division also participates in the preparation of legal opinions requested of the Attorney General.

The Division of Law Enforcement Services analyzes forensic physical evidence for state and local law enforcement agencies. The division includes the state repository for fingerprint identification and criminal history record information and operates a 24-hours-a-day, seven-days-a-week statewide computerized telecommunications system linking law enforcement agencies. The division also administers recruitment and training standards, which apply to all Wisconsin law enforcement officers, and provides training at advanced levels.

The Division of Criminal Investigation investigates crime that is statewide in nature or importance. The division enforces laws pertaining to gambling, prostitution, narcotics violations, white collar crime, computer crimes, government corruption and crimes against children; investigates fires of unknown or suspect incendiary origin; and assists local law enforcement in the investigation of crimes against persons and property. Upon request, the division assists local law enforcement agencies in cases involving homicides and

multi-jurisdictional theft or fraud. The division also performs special investigations requested by the Governor or the Legislature. In addition, the division provides extensive training to local, state and federal officers on current issues in law enforcement.

The Division of Management Services is responsible for operational support, which includes policy analysis, budget, information technology, and fiscal and human resource services.

The Office of Crime Victim Services helps victims exercise their rights and access services, and provides financial assistance to victims and to the programs that serve them. In addition, the office advocates for public policy and resources to enhance and expand victims' rights and services; informs the public, professionals and policymakers about crime victim issues; and educates, trains and provides technical assistance to professionals assisting victims of crime.

MISSION

The department's mission is focused on public protection and defense of the state in litigation.

1. Increase Employee Contributions to Pension and Health Insurance

The Governor recommends increasing state employee contributions towards pension and health insurance costs. Employees will generally pay 50 percent of the total required retirement contribution, which for calendar year 2011 equals 5.8 percent of salary. The Governor further recommends increasing employee contributions for health insurance from approximately 6 percent of the premium to 12.6 percent of the premium. These modifications are necessary to bring state employee compensation in line with private sector employment and reduce compensation costs.

9. Convert Threat Liaison Officer Funding Source

The Governor recommends moving the funding and position authority for the Threat Liaison Officer program from a program revenue funded appropriation to a federally funded appropriation, and extending position authority for a 1.0 FTE project position from June 30, 2011, through June 30, 2012. The Threat Liaison Officer program is supported through federal homeland security grants awarded by the Office of Justice Assistance.

10. Discretionary Legal Settlement Funding

The Governor recommends transferring from the department to the Supreme Court and Department of Administration discretionary legal settlement funds to fund criminal justice programs. The funding transferred to the Supreme Court in FY12 will purchase electronic archival materials for the State Law Library. The funding transferred to the Department of Administration will provide additional resources to fund a program that allows law enforcement agencies to receive decommissioned excess equipment from the U.S. Department of Defense at greatly reduced cost. 11. Penalty Surcharge Deficit Reduction

The Governor recommends adjusting the distribution of revenue from the penalty surcharge program to reflect current projections. These adjustments include: (a) implementing a 10 percent across-the-board reduction to penalty surcharge recipients; and (b) requiring all unencumbered balances in penalty surcharge appropriations to revert to the main collection appropriation at the end of each fiscal year.

12. Victim Surcharge Restructure

The Governor recommends creating Part C of the victim and witness assistance surcharge to accurately track revenues dedicated to victim compensation and sexual assault victim services. This change will not increase the overall fee amount, but rather split the fee into three distinct parts instead of the two under current law.

13. Administration of Sexual Assault Victim Services Grants

The Governor recommends amending statutory language for the appropriation in the Office of Crime Victim Services that awards grants to sexual assault victim service providers to also allow administration of the grant program from that appropriation.
