Fiscal Year Mismatched Vouchers - SCO Correcting

STAR has provided the Controller's Office with a list of vouchers where the Actuals Ledger (GL) fiscal year is different than the Commitment Control (KK) fiscal year. There are approximately 341 mismatched vouchers that fall into 3 categories that require correction:
